What is Open Access?

Open Access is the principle that a research output should be presented in a form that allows anyone with internet access to search electronically within the text, read it and download it without charge.

The copyright holder of an output can make it open access by applying an open access licence to it.

For example, a journal article, book, or dataset with an open access licence can be accessed by anyone, and there will be no (or very few) restrictions on how people can reuse the item.



Publications - Routes to Open Access

Publisher version freely available (often paid for by author or their employer)

- Output is immediately freely available
- Usually payment of a fee - Article or Book Processing Charge (APC/BPC)
- Also known as 'gold' or route 1.

Accepted version freely available ('no cost')

- Deposit (usually accepted final version) in online repository
- Often an embargo period to making this visible
- Also known as 'green' or route 2

The Research Publications and Copyright Policy is a tool to support this option.

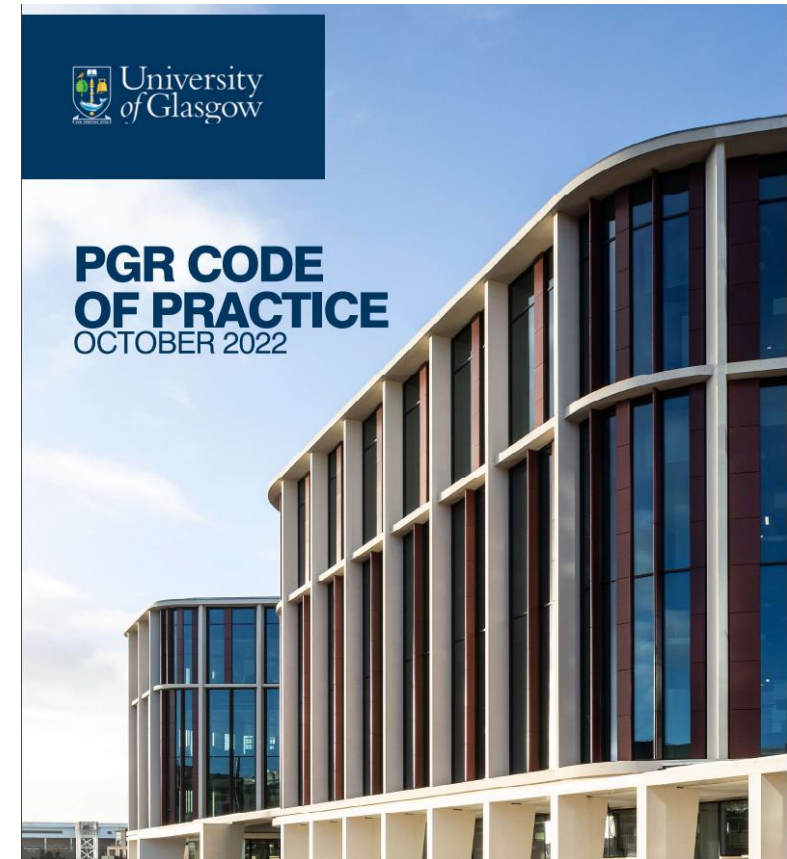

Research Excellence Framework



- **Original research**
- **First made publicly available between 1 Jan 2021-31 Dec 2028**
- **Has a substantive link to UofG, evidenced through an author's 'eligible employment relationship':**
 - Minimum 0.2 FTE continuous employment for at least 12 months
 - A role descriptor that included explicit expectation of research
- **Eligible employment relationship occurred either:**
 - At the point at which the submitted output was first made publicly available **OR**
 - Before the submitted output was made publicly available (ie. When the underpinning research was carried out at UofG; typically between Jan 2021-Dec2028 but may be extended 1 years' prior for most outputs and by 5 years' prior for longform/diverse outputs; tbc by REF panels)
- **Exclusions**
 - Sole authored papers where only substantive link is postgraduate research studentship, visiting/honorary staff post, teaching only contract (AEF1), or staff on contracts with no explicit expectation of research
- **Exception**
 - If a case can be made that the University supported research underpinning the output

REF Open Access Policy



REF Open Access (OA) requirements apply for journal articles and conference proceedings (but no requirements for longform outputs for REF2029).

Requirement	Article or conference proceeding published <u>on or before 31 Dec 2025</u>	Article or conference proceeding published <u>on or after 01 Jan 2026</u>
Deposit author's accepted manuscript (AAM) in a repository:	As soon as possible after acceptance , and no later than 3 months after this date.	As soon as possible after acceptance , and no later than 3 months after publication date.
Maximum allowable embargo periods	<ul style="list-style-type: none">• 12 months for Science, Technology & Medicine (Panel A/B)• 24 months for Arts & Social Sciences (Panel C/D)	<ul style="list-style-type: none">• 6 months for Science, Technology & Medicine (Panel A/B)• 12 months for Arts & Social Sciences (Panel C/D)
Open access requirement	Must be openly available.	Open licence e.g. from Creative Commons suite . Where the route is sharing the AAM and the publisher does not allow an open licence, that is permitted.

- Follow the established [open access process at UofG](#). There are limited exceptions. If the AAM is supplied, the Library can release it after any publisher embargo.
- Consider requirements pre-submission; adding a rights retention statement at first submission can reduce risk of non-compliance.
- Act upon acceptance by sending the acceptance email and AAM to research-openaccess@glasgow.ac.uk

Open Access Licencing Requirements



‘Outputs should be shared as openly as possible; the funding bodies’ strong preference is for licensing as **CC-BY** or other license formats meeting this standard of openness. However, licensing outputs at **CC-BY-NC** or **CC-BY-ND** (including **CC-BY-NC-ND**) or licenses meeting an equivalent standard of openness are also permitted.

For the period 1 January 2026 to 31 December 2028 outputs shared by deposit (AAM), where subject to terms of a publication agreement limiting sharing and/or use of downloaded materials will not need to fully meet these licensing standards. They will however need to meet all other conditions for deposit, discovery and access. Application of an exception will not be required. From 1 January 2029 all future in-scope outputs will need to fully meet open licensing standards, subject to any permissible exceptions’

The processes for outputs selection are now being formalised, including:

- UoA's convening formal **Output Scoring Committees (OSC)**
- OSC's developing an **output scoring methodology** that details how they will approach output selection fairly and equitably.
- Launch of the **institutional outputs tool (PROMPT)** in May 2025, to track scoring and selection of outputs – further training sessions scheduled for Sept 2025
- **UoA outputs calibration exercises with external reviewers** to ensure OSC's are confident in understanding what constitutes a high-quality output for REF.

What do you need to do/consider?

- **Keep publishing your best work** - aim for quality over quantity
- **Consider the REF open access requirements and act on acceptance** - send author accepted manuscript to research-openaccess@glasgow.ac.uk.
- **Ensure your outputs are in Enlighten** – this will make sure your outputs are pulled into PROMPT and be visible to the OSC for review.
- **Look out for CKU resources available on our [UofG REF2029 intranet](#).**

Open Access Compliance Checking



- The open access team add relevant exceptions and codes to records as received
- UoA's responsible for some checks e.g. staff contract status
- UoA's should check they are content with the robustness of any codes suggested
- PROMPT selections tool for those who are making selections
- Open Access dashboard for those who are checking open access compliance

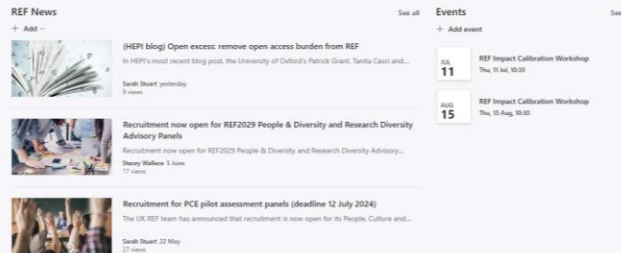

Acknowledge Funders (or that none)

Acknowledgement of funding should be a sentence with the funding agency written out in full, followed by the grant number in square brackets (if you have one). For example:

‘This work was supported by the Medical Research Council [grant number xxxx]’.

Multiple grant numbers should be separated by comma and space. Where the research was supported by more than one agency, the different agencies should be separated by a semicolon, with “and” before the final funder. For example:

‘This work was supported by the Wellcome Trust [grant numbers xxxx, yyyy]; the Arts and Humanities Research Council [grant number zzzz]; and the Engineering and Physical Sciences Research Council [grant number XXXX]’

Include a Data Availability Statement

All publications should include a data availability statement that explains where the data that support the publication can be found.

Some funders notably UKRI, Wellcome and Cancer Research UK mandate this.

A good data availability statement will include a Digital Object Identifier directing readers to the data in a repository.

If no data is available a data availability statement should indicate this.

RESEARCH PUBLICATIONS & COPYRIGHT POLICY

The University is committed to ensuring wide access to the scholarly outputs from its research activities, in acknowledgement that making research outputs more readily available increases the potential for community engagement, citation, reuse and impact. Certain major research funders have introduced open access policies which require grant-holders to make their research outputs open access upon publication and to be openly licenced under a Creative Commons attribution licence (CC BY).

The University therefore encourages, and in some cases requires, researchers to provide open access to published research, to meet its ambitions for open research, to enable compliance with research funders who mandate open access, and to ensure University policies align with the requirements of future research assessment exercises.

This ***Research Publications and Copyright Policy*** enables the University and its researchers to disseminate research results as widely as possible, supports and encourages good open access practices with respect to publications arising from University research activity and assists researchers to comply with funder open access requirements.

- A tool to enable creators of research outputs to share the accepted version freely.

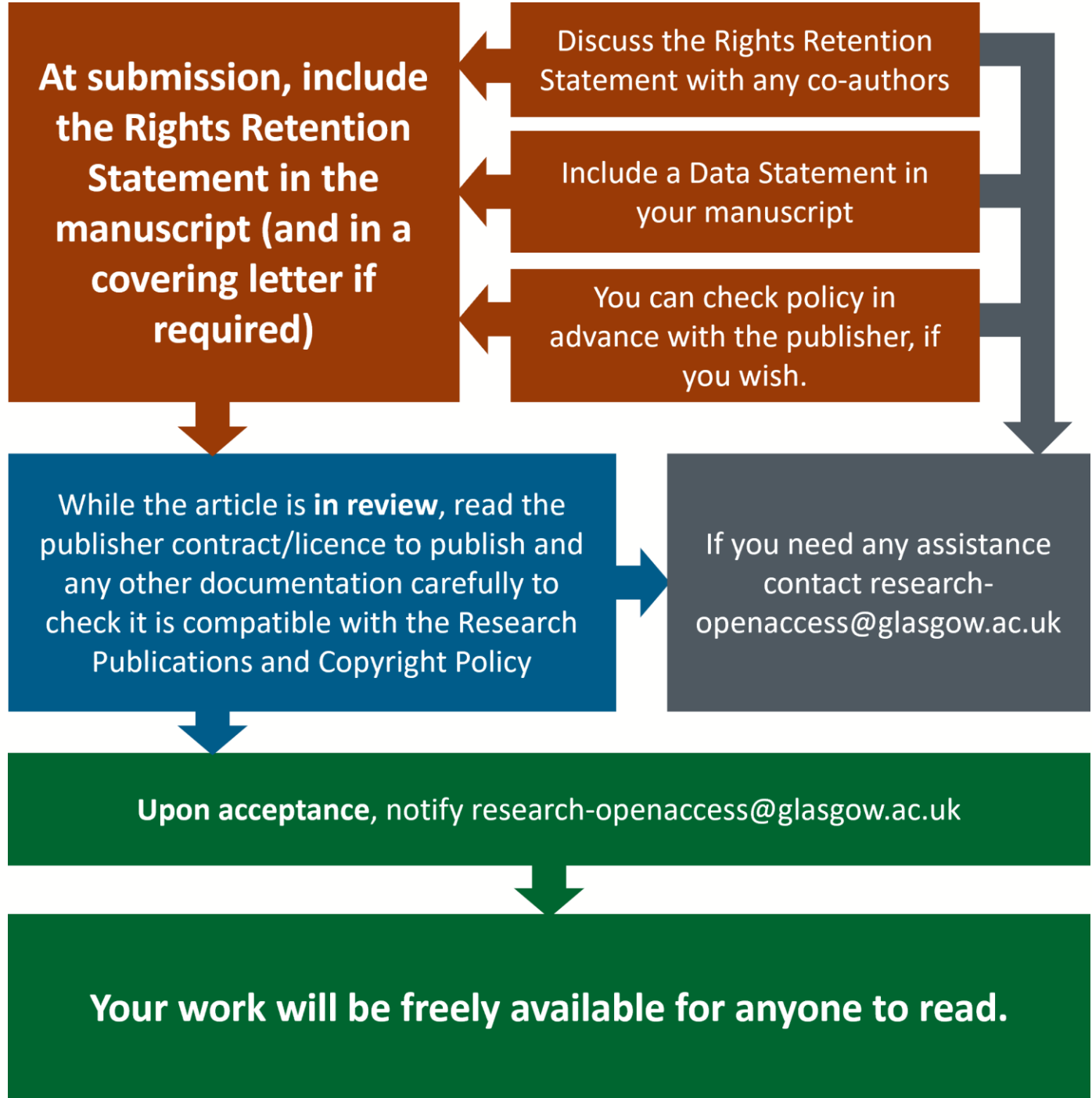

What does the library do?

- Check funder requirements
- Check the publisher copyright policy
- Advise on open access options case by case
- Arrange payment from funder sources if appropriate (page charges generally not eligible)
- Deposit manuscript and release after embargo

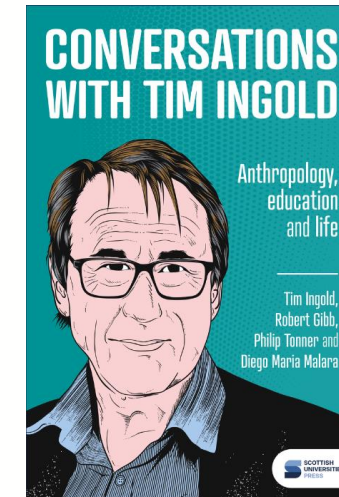

INTRODUCTION

Using the OA Books Toolkit

This Toolkit is aimed at promoting and supporting open access (OA) to academic books. It consists of short articles covering a wide range of topics relating to OA books, each including a list of sources referenced, further reading and links to definitions of key terms.

The toolkit has two main sections. One section is for researchers as authors of academic books, and is intended to help authors to better understand open access book publishing and to increase trust in open access books. The other section is aimed at policy makers and provides a resource to support policy development for OA books. Taken together, the articles should also be of interest to the wider range of stakeholders with an interest in OA books publishing and policy, for example libraries and publishers.

Open access for books

This subsection serves as an introduction to open access for academic books. Topics include what open access is, what its benefits are, common myths about open access, digital and print publication books, the difference between open access and non-open access books and how open access books differ from open access journals.

Contributor Roles Taxonomy (CRediT) Roles

Term	Definition
Conceptualization	Ideas; formulation or evolution of overarching research goals and aims.
Methodology	Development or design of methodology; creation of models.
Software	Programming, software development; designing computer programs; implementation of the computer code and supporting algorithms; testing of existing code components.
Validation	Verification, whether as a part of the activity or separate, of the overall replication/reproducibility of results/experiments and other research outputs.
Formal Analysis	Application of statistical, mathematical, computational, or other formal techniques to analyse or synthesize study data.
Investigation	Conducting a research and investigation process, specifically performing the experiments, or data/evidence collection.
Resources	Provision of study materials, reagents, materials, patients, laboratory samples, animals, instrumentation, computing resources, or other analysis tools.
Data Curation	Management activities to annotate (produce metadata), scrub data and maintain research data (including software code, where it is necessary for interpreting the data itself) for initial use and later re-use.
Writing – Original Draft	Preparation, creation and/or presentation of the published work, specifically writing the initial draft (including substantive translation).
Writing – Review & Editing	Preparation, creation and/or presentation of the published work by those from the original research group, specifically critical review, commentary or revision – including pre- or post-publication stages.
Visualization	Preparation, creation and/or presentation of the published work, specifically visualization/data presentation.
Supervision	Oversight and leadership responsibility for the research activity planning and execution, including mentorship external to the core team.
Project Administration	Management and coordination responsibility for the research activity planning and execution.
Funding Acquisition	Acquisition of the financial support for the project leading to this publication.

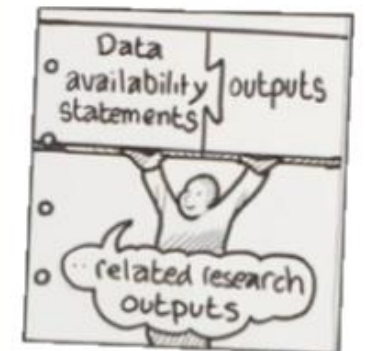
